CSA Directors provided updates on their respective departments: Communications, Amanda Sutcliffe-Jones; Finance and Administration, Victoria Shanahan; Maintenance, Enhancement and Major Projects, Russell Fredericks; Operations and Special Projects, David Henderson and Safety, Security and Transportation, Toby McSwain.

# **Financial Update**

Mr. Borghesi provided an update:

- o There is a total of \$985,000 in rollover projects and \$60,000 in new projects;
- \$750,000 related to North Sea Pines Drive reconstruction project, did not get completed in 2020;
- Beach Shuttle trolley operation discussed at length in Executive, Gate Entry and Short Term Rental Committees. Committees agreed to operate the Beach Shuttle in 2021 and to implement the \$2 Beach Shuttle fee.

# Approval – Amendment, Budget, 2021
