# Call to Order

The meeting was called to order by Stu Rodman, Chair, at 9:00 a.m., Eastern time.

### **Establishment of Quorum**

With the majority of Committee Members in attendance, quorum was met.

## Ratify Approval – Committee Meeting Minutes, September 24, 2020

o Review of Strategic Plan is an ongoing, 2 year process.

#### **Discussion**

Update on 2017 Strategic Plan Goals

Chair Rodman and Mr. Bennett provided updates:

- Top 3 Goals: Form of Governance, Quality of Life Execution and Financial Capability;
- Form of Governance, strategies included: open committee meetings, video conferencing/Zoom, leadership development;
- O Quality of Life Execution, strategies included: gate traffic flow, (Gate Entry and Safety and Security Committees), storm water infrastructure (MEMP and Finance Committees), current community appearance upgrade (MEMP Committee), future community attractiveness upgrade (MEMP Committee), leisure trails upgrade and expansion (MEMP Committee), community wide events (Communications Committee), natural amenities preservation and enhancement (Strategic Planning Committee) success oriented

- environment (Strategic Planning Committee), Forest Preserve development (Strategic Planning Committee), Sea Pines Amenities expanded and developed (Strategic Planning Committee);
- Financial Capability, strategies included: Reserve Fund, performance, revenue enhancements, borrowing, Referendum 2020. Lack of financial capability has halted some work.

## Development of Quality of Life Strategies

Chair Rodman and Vice Chair Tucker provided an update:

- Topics of discussion included: marketing and branding, amenities, short term rentals, Sea Pines Circle and Sustainability;
- Marketing and Branding Task Force to meet in January. Task Force to provide opinions on the 8 opportunities. Eight opportunities included: marketing the community, promoting why Sea Pines is a great place to live, attracting remotely working families, attracting those fleeing south, polishing the brand, build on RBC Heritage, build on history, recover property values;
- o SWOT Analysis reviewed and attached to minutes of record;
- o Continue to review community center concept, assess community interest, survey;
- o Short term rentals, how to monitor large houses with too many occupants, cars/parking/ commercial use, challenge for security on regular basis. Sea Pines trending to a second home and short term rental community. Fabric of community changes, more teardowns with rebuilds in 5 − 6,000 square feet range, check insurance coverage category;
- Three entities could be approached regarding marketing: Sea Pines Resort, Sea Pines Realty, Chamber of Commerce;
- Solicit feedback from Riverstone/Goodwin family. Why Sea Pines for investment. Invite to meeting;
- o Increase growth on Island leads to Sea Pines Circle failure. Safety and Security Committee to monitor/review work on Circle to Circle Committee and bridges;
- O Sustainability, build awareness, create pamphlet for RPOs on how to protect home, i.e., build pools higher, install HVAC units 4 feet above ground.
